At the March trial, we initiated the practice of having one judge rotating between two rings on the first day of the trial. We will be taking a survey of the exhibitors to see how they liked it.

The March trial was our third trial of the season, following trials on October 16 - 19, 2014 and January 22 - 25, 2015. This was our first full season in our new home in Ring 2 with the new agility trailer and equipment. Over the course of these three trials we have been breaking in the trailer and equipment and getting to know our new ring better.

In addition, MOC provided support to Greater Miami's 2-day December trial in Miami and to OTCPB's 3-day February trial in Fort Pierce. Overall, this has been a very successful trialing season for MOC.

The next stop is Arcadia to support the OTCPB trials in June and August.

## BEHIND THE SCENES:

We exhibitors have all made that happy journey. After confirming that we earned a new leg or a new Q, perhaps even a new title, the next stop is the awards table to pick up the ribbon. For the beginning handler, every new ribbon is a treasure. For even the most experienced and successful of handlers, there are certain ribbons that won't be passed up. Those ribbons don't grow on trees and lay themselves out on the awards table. They are the responsibility of the Awards Chair.

Trina Chicvara has been an MOC Member since 1994 and has held countless positions over the years. For the past 3 years, she has served as our Awards Chair. Her job as Awards Chair begins long before the trial takes place. She starts with an inventory of ribbons on hand. Then she estimates the number of ribbons that will be needed in the future and places the order for those new ribbons. When the ribbons are delivered and accounted for, Trina organizes them so they will be available to the exhibitors. On the day before the trial, Trina is on hand to set up the awards table. Then, throughout the trial Trina stays at her post at the awards table to make sure that everything goes smoothly. When the trial is over, she packs things away. She then starts the process again for the next trial.

## AWARDS CHAIR



In addition to the ribbons, the Awards Chair is responsible for the exhibitors' gifts. Trina maintains a treasure chest of toys, treats and other special finds that are available to trial exhibitors. She goes to great lengths to make sure that exhibitors are provided with quality choices. There is no online ordering for Trina when it comes to these goodies. She shops at a number of different stores throughout the year to make sure that exhibitors are offered the best selection and that MOC gets the best deals. 
