**NON-REGULAR CLASS DESCRIPTIONS:**

The WILD CARD NOVICE, OPEN AND UTILITY Classes are for any dog that is capable of performing the Obedience exercises and that is eligible under the **Obedience Regulations** to compete in AKC events. No title is required to enter and handlers may enter more than one dog. Dogs in these classes maybe handled by the owner or any other person, and may be entered in another class or classes. The Novice, Open, and Utility exercises will be performed and judged as in the regular classes except that verbal praise during the exercises is to be encouraged and not penalized. (Good, yes, nice, super, great, atta boy, are some examples of praise that would be allowed.) Handlers may give additional commands, but they will be penalized accordingly. Each handler may choose to select one exercise as a wild card. The exhibitor will have the option of performing the selected wild card exercise, but will receive the full point value regardless of how the dog performs. When checking in, the handler must inform the steward or judge which exercise will be used as the wild card. The exercises will be performed in the same order as the regular A classes. The point values for the exercises, scoring, and maximum total points are the same as the regular Obedience Classes.

A Dark Green Qualifying ribbon will be awarded to all dogs receiving a qualifying score in a Regular Class and Optional Titling Class. Qualifying scores from the Optional Titling Classes are not eligible for Regular Class prizes or High in Trial.

**TROPHIES**

A qualifying score is required for all Regular Class and Optional Titling Class prizes and ribbons. All trophies must be picked up at the Trials—none will be mailed.

Obedience – an AKC Recording Fee of \$0.50 for the first entry only and a \$3.00 Event Service Fee per entry will be collected. There are no Recording/Event Service Fees for Obedience Non-Regular Classes.

Rally – an AKC Recording fee of \$3.50 per entry will be collected & \$3.00 for each additional entry of the same dog.

(The recording fees are included in the entry fees)

## **NOTICE TO EXHIBITORS:**

Entry fees shall **not** be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Event Committee. Bitches in season are not permitted on the show ground. If a bitch is withdrawn from competition because she came into season and the trial secretary is notified at least one half hour prior to the start of the first class, the entry fee will be refunded, minus a \$5 service fee. Unentered dogs are not allowed on the show grounds.

ALL DOGS SHOULD BE PRESENT at least 30 minutes prior to judging. The handler is solely responsible for having the dog at ringside. **The steward will not search for you.**

**No food will be available at the site. There are fast food restaurants available in the area. Please plan accordingly.**

**Exhibitors will be responsible for picking up after their own dogs.** Once identified, those who do not pick up after their dogs will be excused from the trial and trial site WITHOUT a refund. Please help us keep the show and motel grounds clean **so that we may use them again.**

Children must be accompanied by an adult and under control at all times.

“Exhibitors should follow their veterinarian’s recommendation to assure that their dogs are free of internal and external parasites, any communicable disease, and have appropriate vaccinations.”

## **TRANSFERS (FORMERLY MOVE-UPS):**

After a dog earns a title in either Obedience or Rally, it may transfer to the next class in a future trial even though the closing date of the trial has passed. The transfer may be requested if, according to the owner’s records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made.

The request for a transfer must be in writing and presented to the trial secretary for Trial #1 on Saturday, May 27, by Monday, May 22 at 6:00 PM. Transfers for Trial #2 on Saturday must be submitted in writing ½ hour before the start of Trial #2. Transfers for Trial #3 on Sunday, May 28, must be submitted by the close of the trials on Saturday. Transfers for Trial #4 must be submitted ½ hr before the start of Trial #4. Transfers may be approved, provided the next level class and judges are available and the class has not reached its limit.

## **TRANSFERS – RALLY EXHIBITORS PLEASE NOTE:**

Because of possible Transfers, jumps heights must be supplied on your entry form for ALL Rally classes. The trial secretary will not accept your entry without jump heights—examples of Transfers: Rally Novice to Advanced; Rally Advanced to Excellent. The trial secretary will not contact you for this information.

## INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes; please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the **AKC Canine Partners<sup>SM</sup> Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
